### An Introduction to the Committees of the Governing Body

- Much of the work of the governing body is done through its committees. These are sub-groups of the governing body and, by and large, have to be run in accordance with the same legislation as the governing body.
- The governing body may choose to delegate certain of its functions (although not its responsibilities) to its committees, so that they may make decisions on behalf of the governing body. Alternatively, a committee may be asked to consider issues and to make recommendations to the governing body which are then taken by the governing body as a whole.
- To be quorate a committee must have three voting members present.
- Any governor can be co-opted onto a committee for a particular meeting.
