9	Status of the Committee	<p>Following the Schools conversion to Academy status, the charitable status of the PTFA has become ambiguous. The Chair explained that under current legislation, the PTFA would be considered a charitable organisation, subject to the same rules as registered charities. Similarly, committee members would be considered trustees. It was agreed that the current arrangements had become untenable. The Chair proposed that Wes Wilkes will investigate applying for our own charity status and nominate committee officers to be trustees. As a result, a new constitution will also be required. Proposed Philip O'Rourke, Seconded Kerry Bonfiglio-Bains. The meeting agreed to these items.</p>	
10	Parent Engagement	<p>We now have a situation where parent-engagement has faltered. We need for every parent to understand that they are part of the school community.
